TOURNAMENT RULES

- Handicap based on 90% of 230.
- Entering average:
 - a. **Highest** of 2022-2023 USBC Certified Book Average.
If no book average for 2022-2023, then the current year average with a minimum of 21 games as of December 31, 2023 may be used. Bowlers with neither of the above averages must bowl scratch based on 230.
- Open to those of Asian descent and spouses of persons of Asian descent. Non-Asian participants must be an active member of a Nikkei league/association. An active member is defined as having an established average and bowled 15 games prior to entry close date.
- All entrants must be current members of USBC.
- 4 person Mixed Team must have at least **one man OR one woman;**
- **4 person Mixed Team, Squad 2, must have at least two different bowlers than Squad 1.**
- At least 1 prize for every seven entries in Mixed Doubles and Mixed Teams.
- SBC Rule 319a through 319e will be observed: Rule 319a, Line 2 will be excluded.
- It shall be each bowler's responsibility to verify the accuracy of his/her average whether submitted by the bowler or others. Failure to use a proper average or make a correction prior to or up to the completion of the first game of a series shall disqualify score if submitted average is lower than actual average. Prize winnings shall be based on submitted average if it is higher than actual average.
- **Bowlers without a 2022-2023 USBC Certified Book Average must complete the current year average verification section and attach a copy of league standing sheet showing average as of December 31, 2023 and submit by entry deadline. Failure to comply will result in bowler using a scratch average.**
- Tournament managers reserve the right to reject or rerate any entry. Such rerating must be done before entrant bowls; if the bowler does not accept the rerated average, the entry fee shall be refunded.
- Squad check-in will begin 20 minutes prior to start time. Tardy bowlers must start from frame in progress; no make-up frames.
- All decisions of the tournament managers are final unless an appeal is made in accordance with USBC Rule 329.
- Entries not accepted after all squads are filled.
